## 至申根國旅遊 Travelling to the Schengen area

自 2011 年 1 月 11 日起，台灣護照持有者已不需簽證即可進入歐盟進行在 180 天內累計停留期間不超過 90 天。此短期停留免簽證待遇適用於所有載明持有人身分證字號的台灣普通護照。該護照必須是在最近十年內核發，且必須在你預計離開申根會員國時，最少仍有三個月的有效期。

Since 11 January 2011, for short term visits of up to 90 days within a period of 180 days, no visa is needed by holders of Taiwanese passports to visit the Schengen area. The visa exemption applies to all ordinary Taiwanese passports which contain the identity card number of the holder. The passport needs to have been issued within the previous 10 years and needs to be valid at least 3 months after the intended date of departure from the territory of Member States.

免簽證待遇不適用於未載明持有人身分證字號的台灣護照。

The exemption from the visa requirement does not apply to holders of passports issued by Taiwan which do not include an identity card number.
